1 Introduction to Princeton ERA

This is an introduction to Princeton's proposal and agreement system. It covers basic information about how Princeton ERA works and interacts with other systems on campus.

1.1 What is Princeton ERA?

Princeton ERA is the solution Princeton uses for sponsored research proposals, sponsored program agreements, and RCR training. The system will be used by department administrators, grants managers, principal investigators, and ORPA to track, workflow, approve, and submit proposals and agreements.

Princeton ERA is our customized version of two modules called Huron Grants and Huron Agreements. Our system is a SaaS (Software as a Service) solution; This means there will be continual updates and improvements to the software. You will be alerted of any major changes. This also means that we have only made limited customizations to the Huron product and cannot customize more. But as Huron community members, we will be actively engaged in requesting enhancements and future updates to the product.

It is important to note that the Awards module has not been implemented for Princeton ERA. Awards will still be setup and maintained in PeopleSoft Financials. Similarly, subaward requests and negotiations are tracked in Princeton ERA, but the PO and invoice approvals will remain in PeopleSoft.

Princeton ERA is replacing Coeus as of August 31, 2020. Coeus proposals will be available in a read only format, however all future pre-award activity will be conducted in Princeton ERA beginning on this date. No Coeus proposals have been converted. Active fully executed agreements have been migrated to Princeton ERA and will appear in the Agreements module with the pre-fix "MIG."

1.2 Princeton ERA and Other Campus Systems

1.2.1 Princeton ERA and the Hub

"The Hub" which contains PeopleSoft HCM data is the source of people and departments for Princeton ERA. Individuals or departments that exist in PeopleSoft HCM are created and/or updated in Princeton ERA via a nightly feed. Examples of updates include name changes, department transfers, or active/terminated statuses.

1.2.2 Princeton ERA and PeopleSoft Financials

Proposals are created and routed in Princeton ERA. When a proposal is funded by the sponsor, it will be interfaced to PS Financials so that it can be setup as a PS Award. The ORPA award specialists will setup the award and send the Notice of Award. Once the award has been setup in PeopleSoft, it will send a message back to Princeton ERA that marks the proposal as "Awarded" and adds the PS Award ID to the proposal workspace.

New sponsors are created in Princeton ERA and they interface to PeopleSoft. If a new sponsor is needed for creating a proposal, an ERA team member will create the sponsor in Princeton ERA so it can be used on the proposal. The sponsor will interface to PeopleSoft overnight and appear in PS sponsors the next day.

1.2.3 Princeton ERA, eRIA, and Additional Compliance Info

Princeton ERA will interact with several compliance related systems and feeds.

eRIA

eRIA is a suite of electronic management systems supporting Research Integrity and Assurance (RIA). New sponsors are created in Princeton ERA and they interface to eRIA, similar to how they interface to PeopleSoft. The sponsor will interface to eRIA overnight and appear the next day.

In the future, eRIA data for IRB protocols, IACUC protocols, and IBC registrations will be integrated with Princeton ERA. When creating a proposal, users will be able to select the protocols or registrations applicable to their protocols instead of entering them manually. Stay tuned for details about when this future functionality will be launched.

COI

Conflict of Interest disclosure and training information is available in Princeton ERA. Training information is received from CITI and disclosure information is received from Princeton's electronic conflict of interest system. Department Administrators and ORPA staff can view disclosures and training information for senior/key personnel on their funding proposal.

RCR

Responsible Conduct of Research training information is stored in Princeton ERA. Training information is received nightly via CITI and the Registrar and stored on the trainee's person record. Most users view RCR data via Info Warehouse reports and will not view the RCR information directly in ERA. Please review the RCR reporting manual for additional information.

1.2.4 Princeton ERA and the Info Warehouse

Reporting is done out of the Information Warehouse (IW). IBM Cognos is the software the IW uses for reporting. Data from Princeton ERA will be sent to the IW for funding proposals, agreements, and RCR training.

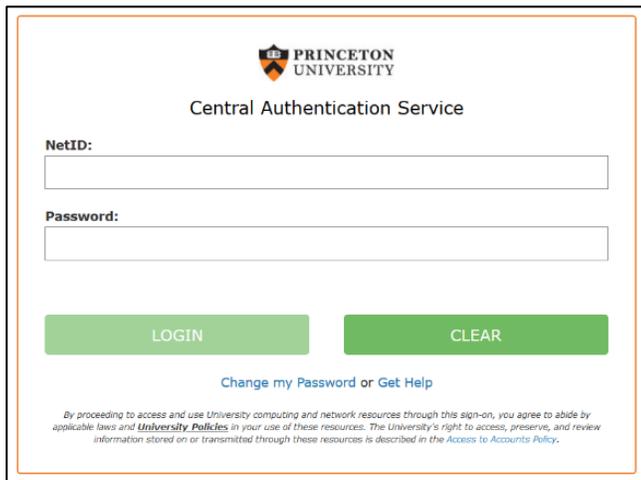
2 Princeton ERA Access and Support

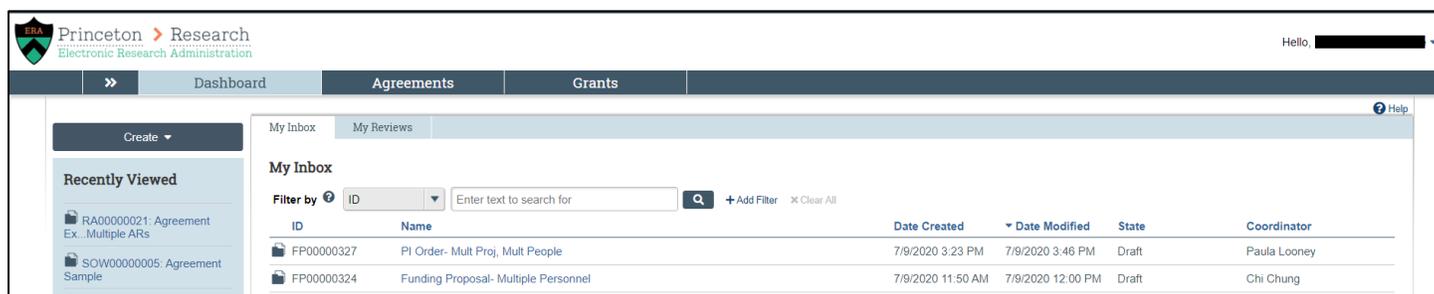

2.2 Princeton ERA Security and Access

2.2.1 Princeton ERA Security

All members of the Princeton research community have access to the Princeton ERA system. Your role and department affiliation determine the actions you can take and records you can access.

Department Administrators

Department administrators can create and submit funding proposals or agreements in Princeton ERA.

On funding proposals, department admins can view and take action on the proposal when they are the admin contact or are listed as an editor. All department administrators will automatically default as editors for funding proposals where their department is listed as the responsible department. Department admins can view and take actions on agreements when they are the admin contact or listed as an agreement collaborator. The specific actions and updates that can be made will be dependent on the state of the agreement or funding proposal.

Department Approvers

Department approvers can approve funding proposals that are submitted for department review. They can access view only versions of the funding proposal and budget for their review. Department approvers will typically have access to all funding proposals within their department because they will default as an editor for all funding proposals where their department is listed as the responsible department.

ORPA

ORPA staff will have access to all proposals and agreements within Princeton ERA. ORPA GCAs will be able to workflow, approve, and submit funding proposals and agreements. ORPA Award Specialists will be able to view all funding proposals and agreements; they can update awarded funding proposals status and interface them to PeopleSoft for award setup.

Central Administrators

Central administrators within the research community may be granted access to view all funding proposals and agreements.

2.2.2 Request Access to Princeton ERA

3 Overview of the System

This overview contains information about funding proposals and agreements, important system terms, and an introduction to basic navigation within the system.

3.1 Funding Proposal and Agreement IDs

Funding Proposals: Proposals in Princeton ERA are called funding proposals and are created within the grants module. Each funding proposal has its own record. Funding proposals may be called "FP" for short and are identified by their FP ID which is a 10-digit alphanumeric value starting with FP (e.g. FP00000001). All funding proposals are automatically numbered sequentially.

- **Budgets:** Funding proposals may have one or multiple budgets. They may also have associated cost sharing budget or subaward budgets. The budgets will be linked to the funding proposal. Budgets will be identified by a 10-digit alphanumeric value starting with BU.

BU00000661

- **SF424:** Proposals that will be submitted system-to-system will have an associated SF424 record. The SF424 will be linked to the funding proposal. It can be identified by the SF424 ID which is a 15-digit alphanumeric value starting with SF-424.

Agreements: Agreements such as research agreements, subawards, or data sharing plans are created within the agreements module. Each agreement has its own record. Similar to FPs, agreements can be identified by a 10-digit alphanumeric value. The prefix of the agreement will be based on its type. All agreements are automatically numbered sequentially within their agreement type.

3.2 System Terms and Definitions

Terms	Definition
Dashboard	The Dashboard is the landing page when you log into Princeton ERA. It is a starting point for creating proposals and agreements or finding items. The dashboard lists your items which needs specific action or have been recently reviewed. You can select the create button to begin a new submission.
Workspace	Each funding proposal and agreement has its own workspace. The workspace is a view that contains summary, links, status images, and tabs of relevant information regarding that proposal or agreement. “Workspace” is the term for this page and has nothing to do with Grants.gov Workspace.
SmartForm	Users complete a SmartForm for each proposal, agreement, or budget. SmartForms are online forms that contain a series of questions to collect demographic and budgetary information for the submission. They are called “Smart” forms because they hide/show different questions based on how certain questions are answered. This is also called “branching.”
Workflow	Funding proposals and agreements will move through workflow until they are awarded, terminated, or activated. Workflow refers to the process of moving a submission through the system.
Activities	Users execute activities for a funding proposal or agreement on the workspace. Activities are actions that can be taken by the user for that submission. Some actions include moving the submission through workflow, other actions may include checking compliance info or sending notifications.
Notification	Notifications are email messages that will be sent from Princeton ERA to Outlook email.

3.3 Basic Navigation

This section will provide you an introduction to basic navigation of the system. Manuals on creating a funding proposal and agreement provide in depth step-by-step instructions.

When you log into Princeton ERA, you will be presented with your **Dashboard**.

The Dashboard will show you a list of all funding proposals or agreements that you can take action on (My Inbox) and just those requiring review action (My Reviews)

From the Dashboard, you can select create to start a new proposal or agreement.
